

OPENING:

The regular monthly meeting of our Church Council, held at the United Evangelical Church (Friendship Hall), was called to order on Tuesday, July 7th, 1964 at 8:12 PM by our President Mr. F. Long and opened with prayer by Pastor Rasche.

SECRETARY REPORT:

The reading of the minutes of the meeting held on Tuesday, June 2nd, 1964 were read and approved.

TREASURER REPORT:

The report of receipts and expenditures were read, discussed and approved.

REPORT OF STANDING COMMITTEES:

Property - Chairman Mr. G. Sauer

Tiling of Steps (Friendship Hall) - Received two bids as follows:

\$175.00 for treads & risers

\$138.00 Nine treads only no risers.

A motion was made by Mr. W. Single and seconded by Mr. E. Myers to accept bid from Lincoln Tile & Linoleum Co in the amount of \$138.00

Window Cleaning - Contract received from Hearn & Morrill & Co to clean four times per year at \$61.00 per cleaning on the following:

Church School Windows - In and out

Parsonage Windows - Out only

Office Building Windows - In and out

The above is bound for one year and then on a term basis, quarter to quarter.

A motion was made by Mr. A. Block and seconded by Mr. E. Weidel that we accept the above contract but add the following clause "15 additional windows (Friendship Hall and Kitchen) and cancel the one we have with Oriole Window Cleaning Co.

Concreting of Pavement - A motion was made by Mr. E. Jones and seconded by Mr. W. Bark that we have the nine blocks replaced on Dillon Street at the bid submitted in the amount of \$165.00

Drapes - Material picked and waiting for date of installation for up stairs front Church Window

Renovation of Church School Building - A list was submitted to each Council member with regards to the suggested work to be done. Mr. Baeton of Eyring Co. was contacted and he will meeting with the Committee members on Saturday, July 18th, 1964 at 2:00 PM and go thru the entire building and review list of work to be done so that an estimated can be submitted to give us an idea as to the financial cost of this undertaking.

Finance - Chairman Mr. R. Single

Absent - No report

Pastor Rasche presented a financial statement thru April 1964 received from

from United Church of Christ Home, Inc.

Total paid thru 12/31/63 - \$ 700.00

Goal for 1964 - 990.00

Paid 1/1/64 thru 4/30/64 - 423.00

Pastor Rasche suggested that we set aside 25% of our income to put in the Benevolence Fund. Some thought should be given to this and it was suggested that the Finance committee discuss this at their next meeting and present their ideas at the following Council meeting.

At this point Mr. Charles Cover of John G. Rolker Co. Inc. was introduced to the Council members and he presented a brief outline of the type of insurance we carry at the present time (copy attached). Mr. Cover then presented the new type of coverage under the heading of "Public Institutional Form of Insurance Contract". There were six points that he outlined, namely

- 1 - Up to date appraisal of buildings
- 2 - Inventory contents
- 3 - 90% coverage after approval of above instead of 80% coverage
- 4 - Agreement for one year, accepted by Rating Bureau Insurance Company from date of contract. Maximum three years, done yearly.
- 5 - Quarterly self inspection
- 6 - Combination in one contract 90% co-insurance clause

It was suggested that each organization be contacted to submit to the Church Council no later than the August meeting a complete inventory of their property.

Mr. Cover was authorized to proceed as to the cost to convert to this new type of insurance protection inasmuch as it would not cost us anything for the estimate or coverage protection.
