

The regular meeting of the Council Board of the United Evangelical Church was held on December 5, 1967.

Those in attendance were Albert Fader, George Sauer, Ernest Jones, William Single III, Richard Single, William Bark, Jr., Louis Mueller, William Baekke, and Louis Barkel, Sr.

The meeting was called to order by President Albert Fader and the meeting was open with a prayer by Pastor Carl E. Kasche.

The minutes for the meeting for the month of November were read and approved as written.

The monthly financial report was reviewed and accepted as submitted. It is the intent of the Council Board to withdraw the \$15,000.00 from The American National Bank where we are presently getting a 4 1/2% return, many board members think we could be getting a 5 1/2% return by buying certificates at a Building & Loan Association. Mr. Bark will write for a quote on these certificates.

Report of Committees:

Property Committee: George Sauer reported that he is getting many of the maintenance items taken

Mr Fader said that the plans for the reception would be worked out after Trnsel Day festivities were over.

Calendar Committee: William Walker suggested that January's Council meeting be changed from January 2 to January 9.

Ushering Committee: This committee is still interested in securing new junior Council members.

Music Committee: We are waiting for Donald Schnadler to get Mr Herbst in to approve the recommendations for correcting the acoustics problems.

Audit Committee: Mr Fader asked this committee to have the audit completed before January's congregational meeting.

Spiritual Committee: Progress. Ernest Jones is waiting on Mrs McHugh on report of Oyster and Sun

Old Business: Ernest Jones assured us that the pine tree roping would be here by Thursday Dec. 7. Al Foden asked the Council Board members for help in hanging the greens in the church the same evening.

The Christmas tree will be donated to the church, and it is a rather large one. William Single said that he would cut it down and Louis Mueller consented to haul it to church in his truck.

Buster Lasche contacted Mr. Crowley of the "Guide" concerning the ad we would like to run in his paper. A 50 word ad on a 48 wk. basis would cost \$5.50 a week - \$264.00 a year. The Council agreed that \$264.00 plus \$72.00 a year which we are now paying through the Chequamegon Association is much more than our budget allows. Lou Smith is going to contact Mr. Crowley to see what kind of an ad he can get for \$150.00 a year.

The United Men's Club, upon recommendation of the Council Board, has made some changes in its Constitution. These changes have been brought to us for approval and read as follows:

Article II - Purpose

Section # 2 - Now reads: "To provide a recreational and social group for the men of the

United Evangelical Church and men of other Protestant churches who desire to become a member of this organization".

Change to read: "To provide a recreational and social group for the men of the United Evangelical Church and men of Other Churches who desire to become a member of this organization".

Article III - Membership

Now reads: "All men who are twenty-one (21) years of age or older, of Protestant denomination and who are in sympathy with the purpose of this organization shall be eligible for membership.

Article IV - Officers

Section #1 - now reads: "The Officers of the Corporation shall consist of a President, Vice-President, Recording Secretary, Corresponding Secretary, and Treasurer. Any member in good standing in the United Men's Club, Inc. shall be eligible to hold office."

Change to read: "The Officers of the Corporation shall consist of a President, Vice-President, Recording Secretary, Corresponding Secretary, and Treasurer. Any Protestant member in good standing in the United Men's Club, Inc. shall be eligible to hold office."

The Council noted that there wasn't always enough men of our Church who were interested in holding office in the Men's Club. The Council also cognizant of the fine job non-members are doing as officers in the Club approved these proposed amendments to the United Men's Club Constitution. Ernest Jones made the motion that we accept these amendments as submitted, and Louis Smith seconded it. The motion was unanimously carried.

Pastor Lasche felt that these members would now feel that they are a part of our Church, and that they would have an active part in the Father and Son Banquet. He also informed us that the last dance that the Club held was of high calibre, and that everybody had a fine time.

Pastor & Mrs. Lasche, Mr & Mrs Albert Fader, recently attended a meeting at Greenbelt where they were advised of the need of a capital fund drive to enlarge the facilities at the Hoffman Home. The amount needed for this project is one million dollars. Our share according to the break-down would be \$7,886.00 over a three year period. Pastor Lasche said that we should not treat this project lightly by just sending off a small amount of money by a single check. He went on further to say that if we couldn't meet the share proposed to us

that perhaps we could compromise a bit. It was decided to take this matter up at the next Council Board meeting; we would still be open to present this to the congregation.

The Council Board decided to have William Single call Reverend Francis F. Bragazini in order to get his consent to circulate the exchange of correspondence between him and our Council Board. Monographed copies would then be distributed to the twenty or so churches in the Chesapeake Association. This would fill them in on the background and perhaps we could arrange for a forum here.

New Business: Election of officers to the Church Council for year 1968.

President: A motion was made by Richard Single and seconded by Louis Smith that A. Albert Fader be elected the President of the Council Board for the year 1968. The motion was unanimously carried.

Vice-President: A motion was made by Richard Single and seconded by William Voller that George Sauer be elected Vice-President of the Council Board for the year 1968. The motion was unanimously carried.

Recording Secretary: A motion was made by Ernest Jones and seconded by William Walker that Louis Parker, Sr. be elected Recording Secretary of the Council Board for the year 1968. The motion was unanimously carried.

Financial Secretary: A motion was made by George Sauer and seconded by Fred Long that Ernest Jones be elected Financial Secretary of the Council Board for the year 1968. The motion was unanimously carried.

Treasurer: A motion was made by George Sauer and seconded by Fred Long that Richard Single be elected Treasurer of the Council Board for the year 1968. The motion was unanimously carried.

Albert Fader thanked William Bark, Jr., Louis Mueller and Arthur Block for the fine job that they all had done, and expressed the wish for them to run again as members of the Council Board.

Patrick Stanton requested a transfer to Epiphany Lutheran Church. Ernest Jones made a motion that Mr. Stanton be commended to his new church and William Walker seconded it. The motion was unanimously carried.

Pastor Lasche received a letter from United Church
of Christ requesting that we turn over the loose
change from our two regular services of Sunday
Dec. 31. This Sunday, it was printed out in the
letter, is the 53rd Sunday of the year, an extra
Sunday in the year so-to-speak. This money
would serve the Christian World Mission well.
Fred Long made a motion we turn the loose
change over to them and William Baekler
seconded it. The motion was unanimously
carried.

Envelopes will be mailed with January's "Endeavor"
for the gifts to our Hoffman Home.

The question came up - Should Mr. Weisser be at our
Council Board meetings. The Council Board voted
yes, as he is a very important part of our organization.
Pastor Lasche informed us that he received a generous
gift from his mother, Mrs. August C. (Theodora)
Lasche. This generous gift of \$300.00 will be
used to install a dishwasher in the parsonage,
which would remain as a permanent fixture.
George Sauer will secure prices for dishwasher
and matching cabinet work. William Park
suggested we send a letter of thanks to Mrs.
Lasche for her generous gift to our church.

the Council Board at this time, the meeting
was adjourned. The meeting was closed with
the Lord's Prayer.
