

August 2, 1994

Those in attendance were Ruth Beckwith, Marty Clement, George Finnerty, George Hammerbacher, George Nassner, Clarence Rowell, James Tallagsen, Cass Young, and Pastor Armstrong.

Pastor Armstrong opened the meeting with prayer.

The minutes and financial reports were accepted as read.

We are \$2580.00 under budget for the month of July.

CORRESPONDENCE:

A letter was received from Lillian Augustus, of Maryland Dept. of Human Resources inviting Pastor Armstrong and Concetta Clark, teacher of Pact Program, to an Orientation Program on August 12, 1994. Pastor will call to ask if George Finnerty, and George Hammerbacher will be able to attend the meeting with him and Concetta.

George Hammerbacher will meet with the Boy Scouts on Wednesday of this week to discuss their requests with their moving to the fourth floor.
