

July 3, 1990

The regular monthly meeting of the Church Council of the United Evangelical Church was held on Tuesday, July 3, 1990, president, Mr. Clarence Rowell, presiding. All members were present except for Mr. Carrigan, Mrs. Young, and Mr. Ben Long. The minutes and financial reports were approved as read.

Correspondence

The Ladies Aid made an offer to donate \$2000 to the church for the alley. However, since the offer was made, they may have rescinded the offer. A motion was made to accept the money from the Ladies Aid for the alley if they are still offering it, and if they have rescinded the offer, to use the installment plan to pay for it. (Parker/Tallagsen). Motion approved.

Pastoral Search Committee

The search committee has recommended that we offer a call to Reverend Armstrong. Mr. Jacobs reviewed the terms of the call with us.

- Motion:
1. We take the recommendation of the committee and offer the call to Reverend Robert Armstrong.
 2. We accept the call as ammended during the meeting.
 3. The call will be signed by Reverend Armstrong, the Council president and the recording secretary.

The motion was approved unanimously. (Jacobs/Parker)

Work is being done on the back doors--once the doors are done the new intercom will be installed. The next project will be the back door on the parsonage. After that the Sunday School doors will be fixed.

We have had no action from the insurance company. Mr. Parker is looking into this, as well as looking into the new volunteers' workman's compensation.

Buck Carrigan has requested a loan of \$1000 until his insurance comes through. A motion was made to give him the loan interest free. (Long/F. Gundlach) The motion passed.

Music

Mr. Parker suggested a memorial fund for the organ. Robert will write up a description of the enhancement for the bulletin. A motion was made to install the enhancer (Rowell/Long). The motion passed.
