This will acknowledge your request for a claim form, which we have enclosed. Under Maryland Law, the claimant has the burden of proving his/her claim. Therefore, you must describe the precise location of this incident and provide the names and addresses of witnesses on the form. If you have a police report number, please provide same.

Generally, it will take about eight weeks for our investigation to be completed. An investigator may be in contact with you for additional information concerning your claim. After the investigation is completed, you will receive a written notice of disposition concerning your claim.

The disposition of a claim may be a denial that the Mayor and City Council is not legally obligated to pay the damages, a referral, an offer of settlement, a denial with a compromise offer, or other dispositions as the facts may dictate.
