

January 5, 1993

The regular monthly meeting of the Church Council of the United Evangelical Church, UCC, was held on Tuesday, January 5, 1993. All were present except Clarence Rowell.

George Hammerbacher, Vice President, presided over the meeting.

The minutes and financial reports were approved as presented.

We are \$7532.00 over budget for the month of December. Five thousand dollars of this was given as a gift from Mary and Philip Thomas toward the purchase of a new copier machine.

A Wish-List was suggested for this year by Bill Voelker to inform the Congregation of our needs for the future.

Harvey Jacob, Financial Secretary, reported that a letter was received from Lighting Product stating we will have to pay for the light bulbs. Harvey sent a check for \$80.00 to them instead of the over priced amount they wanted.

O'Donnell Florist sent a statement to us for \$100.00 for palm stands that were accidentally thrown away. We will send them a \$50.00 check to settle this matter because we feel they were partly to blame because they were notified to pick them up and never did.

A letter was received from Millie, our secretary, asking permission from the Council to let her grandson David work for the church on a volunteer basis for six weeks. This will be therapy for him.
