SECRETARY REPORT:

The reading of the minutes of the meeting hold on Tuesday, February 4th, 1964 were read and approved.

TREASURER REPORT:

The report of receipts and expenditures were read, discussed and approved.

REPORT OF STANDING COMMITTEES:

Property - Chairman Mr. G. Sauer

Fire damage in Church School Building - All bids in and are in the hands of the Insurance ~~company~~ ^{ADJUSTOR}. Additional \$500.00 added for personal property damage. A revised bid to be requested of Eyring to include replacing entire floor and ceiling in Fellowship Hall. Mr. Schwartz requested use of the Fellowship Hall. Eyring to be contacted to see if they can put a temporary covering around the exposed pipe in order to comply with Mr. Schwart's request from the Church School officers.

The Ladies Aid & Young Women's Guild requested need for the following kitchen and dining room supplies:

- 2 bolts tableclothing at \$1.69 per yard (approx. 60 yards to make 18 tablecloths)
- 18 milk pitchers (Optional)
- 18 sugar bowls (Optional)
- 1 dozen carafe pitchers for coffee
- 2 dozen dish cloths
- 2 bolts toweling (100 yards will make about 70 towels) at 29¢ per yard.
