SECRETARY REPORT:

The reading of the minutes of the meeting held on Tuesday, May 5th, 1964 were read and approved.

TREASURER REPORT:

The report of receipts and expenditures were read, discussed and approved.

REPORT OF STANDING COMMITTEES:


NEW BUSINESS:
