The reading of the minutes of the meeting held on Tuesday, December 7, 1965, were read and approved.

Church School - Mr. Paul Bauersfeld, Church School Superintendent requested that public (i.e. printed) recognition be made of donors to the Church School Bible Memorial Fund. After careful deliberation, the Council decided best method would be to prepare express folder for this purpose to be issued on Christian Education Sunday. Mr. Bauersfeld will be asked to weigh this proposal.

Dedication Ceremony - Dedication ceremony of the Church School will not be held in the ~~near~~ immediate future. It was decided by the Council that the stewardship theme of "Break-Thru" - with Lent following, was preeminently important. Possibly something in the nature of a dedication and "open house" may be devised in early summer.

Choir - A discussion on the performances of the choirs was held. On air of general dissatisfaction was evident. Consensus of opinion was that Mrs. Arbelada has never quite fulfilled expectations as either organist or choral director - thus causing an adverse effect upon the action of the choral groups. Mr. Fader, along with several councilmen, is to contact Mr. A. Witzke and seek his candid opinion and suggestions relative to this unfortunant situation.

CLOSING:

There being no further business to come before the Church Council at this time, the meeting was adjourned at 10:40 PM and was closed with Lords Prayer lead by Pastor Rasche.
