

April 12, 1966

The regular monthly meeting of our Church Council, held at United Evangelical Church, was called to order on Tuesday, April 12, 1966 by our President, Mr. J. Albert Fader, and opened with prayer by Pastor Rasche.

The reading of the minutes of the meeting held on March 1st, 1966 were read and approved.

The financial report of receipts and expenditures was discussed and approved.

FINANCE - Mr. Richard Single reported that the receipts for this Easter Season were about \$1,000.00 less than last year.

Mr. Fader reported that \$890.35 was received in memorials.

A motion was made by Mr. William Single and seconded by Mr. Richard Single giving Mrs. Fader the authority to purchase an additional saddle stapler.

Mr. Fader reported that the sexton has resigned, and he will set up appointments starting Monday, April 18, 1966, to secure a new sexton.

Mr. Parker also advised that the Sundayschool will let the congregation have the surplus chairs which they have for a \$1.00 donation. A motion was made by Mr. A. Block and seconded by Mr. W. Voelker to give the Sundayschool permission to handle this matter accordingly.
