

August 2, 1966

The regular monthly meeting of our Church Council, held at United Evangelical Church, was called to order on Tuesday, August 2, 1966, by our President, Mr. J. Albert Fader and opened with prayer by Pastor Rasche.

The minutes of the previous meeting were read and approved. The financial report of receipts and expenditures was discussed and approved.

If Mr. Schnader accepts this offer, there will be a special meeting set up for further discussion on this matter with Mr. Schnader and other members of the Council.

OLD BUSINESS - Mr. Richard Single contacted the insurance company regarding the fan which was missing from the Sundayschool, but they required more information on same. Mr. Single will contact Miss Bertha Will about this matter.

NEW BUSINESS - Mr. Fader then brought up the matter of Youth Fellowship and the Pastor stated that this group should go on as is -- a recreation period but a program will be set up in the near future for something more spiritual and not exactly like the Youth Fellowship. A motion was made by Mr. Arthur Block and seconded by Mr. Richard Single that we continue with Youth Fellowship beginning the first week of October.

The Pastor stated that all Scout groups will be operating this year as there is sufficient help.

Dr. Jack Yates will be guest speaker on October 16th at our services.

The Central Atlantic Conference will have a Christian Enlistment Committee program September <sup>17th</sup> ~~8th~~ at Zion Church, Stemmers Run. The Pastor and Messrs. William and Richard Single will represent our Church.

The Pastor received a price of \$59.00 as the cost of a new insert for the bulletin board outside our church. Mr. Block will get a sample of material and a price from another company for another insert.

In previous year's there have been two World Services <sup>offerings</sup> conducted each year. One of these World Services <sup>offerings</sup> will now be cancelled and in it's place will be a Neighbor's In-Need Program. The World Service Program will be held in the spring and the Neighbor's In-Need Program will be held in the fall.

There was no further business to come before the Church Council at this time. The meeting was adjourned with prayer by Pastor Rasche.
