George Hammerbacher, vice president, presided over the meeting.

The minutes were read and a correction was made.

The financial report was approved as presented.

We are \$8637.00 under budget for February.

Harvey Jacob, financial secretary, had to withdraw \$5000.00 out of Hopkins Federal to put into the checking account for March expenses.

#### Correspondence

A letter was received from Baltimore Gas and Electric Co. informing us our maintance plan for the freezer is due. The cost is \$31.95 for the year. Harvey will renew this plan with the Council's approval.

The wine carpet for the church and quiet room and the blue carpet for the choir room and offices will be started next Thursday. It will cost \$2783.00. Jim has given a \$1400.00 check for the material. The installers may have to work on Sunday if necessary.

The exhaust pipe in the alley was hit by the garbage truck. Jim is going to correct this himself.

Someone stole our copper downspout and Jim and John Strong replaced it with plastic pipe. Jim will also put the steel plate back in place.

Harvey fixed the small safe in the office.

Jim would like to rearrange office and buy new furniture.

To fix the heat problem in the gym George Nassner and Jim will install a new breaker, new wires, and new thermostat. This will be done in the future.

Our custodian has been doing a good job on the windows in the choir room.

Jim suggests the church windows need to be glazed in the near future.

A meeting of the Membership Committee will be set up in the near future.
