He will talk to these people and report back to the Council at our next meeting.

PROPERTY:

It was reported that the roof was leaking in the Choir Room in the closet. George Hammerbacher will get in touch with Jim and have him call the roofer to have this fixed.

A suggested was given about fixing the Church steps. An estimate of \$220.00 was given to do the job.
