Pastor Corinne Baker's Report

The Mission of United Evangelical United Church of Christ is:

We seek to continue Jesus' mission of reaching out, embracing everyone, enriching all, becoming living examples, bonding all with the love of God.

Many people define a "Christian" as somebody who *believes* certain things, such as that Jesus is the son of God, or that all other religions are wrong.

Others think of a "Christian" in terms of what he or she does: helping others, or going to church each Sunday, or reading the Bible, or giving money, or undergoing baptism and confirmation.

Or as Frederick Buechner points out, "some think of a Christian as just a nice guy."

We are nice. But is that why we Christians gather together in God's name on the corner of Dillon and East Ave? To be nice guys and gals?

Let's see what Jesus himself says about who a Christian is, what it means to bear the name of Christ. In John 14:6ff, Jesus said, "*I am the way, the truth and the life*".

In "*The Message the New Testament in Contemporary English*", Eugene Peterson translates these passages this way: "Jesus said, "*I am the Road, also the Truth, also the Life. No one gets to the Father apart from me. If you really knew me, you would know my Father as well. From now on, you do know him. You've even seen him!*"

Just as we would, Philip asks Jesus to show him what he means, and so Jesus responds,

"You've been with me all this time, Philip, and you still don't understand? To see me is to see the Father. Don't you believe that I am in the Father and the Father is in me?"

Philip evidently wonders how Jesus can say these things, and is even more amazed to hear, "*The words that I speak to you aren't mere words. I don't just make them up on my own. The Father who resides in me crafts each word into a divine act.*"

By this time, Philip must have been standing there with his mouth open. Jesus seizes the opportunity to continue his teaching, ***“Believe me...if you can’t believe that, believe what you see – these works.”***

“Hmmm”, Philip begins to get the point.

Jesus continues, ***“The person who trusts me will not only do what I’m doing but even greater things, because I, on my way to the Father, am giving you the same work to do that I’ve been doing. You can count on it.”***

“Uh-oh,” Philip must be thinking, “He’s talking about me... what I must do if I love him....I am to do greater things than Jesus? Wow!”

Jesus is talking about ***you and me*** too, isn’t he?

Did you notice that Jesus didn’t say that any particular ethic, doctrine, or religion was the way, the truth, and the life. He said that ***He was!***

Jesus didn’t say that it was by believing or doing anything in particular that you could “come to the Father.” He said that it was ***“only by Him – by living, being caught up in the way of life that he embodied..., that was his way.”***

Jesus doesn’t want us to miss the point. He says it again: ***“If you love me, show it by doing what I’ve told you.”***

So a Christian, then, is someone who does what Jesus does, and lives as the Master lives. . But is it that simple?

Yes and no. Yes, it’s simple if we think it means doing the work of Jesus individually, on our own.

No, it isn’t simple if we understand that a Christian never lives apart from other Christians. And when we live with other Christians, it means we have a rich mixture of diverse views and ideas about what it means to be like Jesus and do his work.

Buechner defines a Christian as “one who is on the way, though not necessarily very far along it, and who has at least some *idea of whom to thank*. A Christian isn’t necessarily any nicer than anybody else. Just better informed.”

Did you notice that Buechner said a Christian is ***one who knows whom to thank?***

That's where we begin, isn't it?. We begin each day, each Lord's day, by *thanking our Creator* for shelter, food, clothing, just that we woke up to another day on this earth! Then we pray for guidance to live as Jesus lived. And on Sunday mornings we gather *together to thank God!*

I've given a definition of a Christian, a follower of Christ, and what a Christian is to be about, and now I'm turning the tables and asking you!

How do you think we have fared this year as Christians bonded together as the United Evangelical United Church of Christ?

I think we are just rounding first base, and we don't know if we should make the sprint to second. Do you feel this way also?

It seems we are not quite sure what it will feel like to make a bee line over to the next base, and after all, standing with our foot on first base is a safe place to be – by not risking going to second, we can't be put out, or make the wrong decision!

But is that what Jesus meant when he said, "*The person who trusts me will do even greater things. If you love me, show it by doing what I've told you.*"

And so the Church Council has been working diligently this year through an appointed group to *receive the input of the congregation*.

The goal has been to:

- 1) define the beliefs around which this congregation centers its life
- 2) define the mission of the congregation.

From a retreat last February, the council defined the "basics" that are important to our congregation, such as: the Triune God of Father, Son and Holy Spirit, telling and re-telling the faith stories especially at Christmas and Easter to children and adults, music, reciting the Lord's Prayer, the Apostle's Creed and working together in outreach and activities.

Out of these basic understandings last September the congregation was asked to name how we want to live now and in the future as Christ's followers. The congregation was asked to respond to these questions:

- How the Holy Spirit calls us to live now and in the future, (remember the symbol of the dove)
- How Jesus the Shepherd calls us to live through his example, (the symbol of the Shepherd Jesus)
- How We Reach Out to others in Christ's name, (the symbol of outstretched hands)
- With the Eye of God Watching and Guiding us, how will we be and do as Christ's followers now and in the future, (the symbol of the God's Eye).

From the input of the congregation and after much discussion and discernment, the Council Group recommended to the Council a mission statement which was approved. A mission statement simply and clearly tells what ministry we are about at United. A mission statement helps us with our plans and actions by stating the direction we are headed.

United's ministry is too important to Christ and the limited energy of the congregation is too valuable to continue treading water *trying to decide the big if* ---- we should sprint to second, steal third, run back to home, or do all three at the same time. With God's guidance, when *we all know* what "base" we are headed for, we will be able to work together to get there, without going in several directions at once!

A living congregation will never stay the same, but will always be in the process of moving and redefining goals and directions. But for now, we have claimed the following mission statement to point us forward.

The Mission of United Evangelical United Church of Christ

We seek to continue Jesus' mission of reaching out, embracing everyone, enriching all, becoming living examples, bonding all with the love of God.

Now comes the challenging part: *how do we do what we say we seek to do!*

In other words, how will we reach out, embrace, enrich, live and still bond together? Well, some of us will sprint to second while others may jog and still others may walk. But *we will all be headed towards second base*. Many of us prefer things stay as they are, as we stand firm on safe first base, *but if we stay where we are life will go on all around us while we fade away and die as our members age and die. Is this the United Church we want to leave for our children?*

Pray for your Church Council. The Council Group is meeting regularly praying for guidance as future directions and priorities are beginning to be formed around the aspects of the mission statement. Of course, the needs of members, groups and the Church Council will be taken into account as all these different pieces are examined to see if and how they fit into the big picture.

The next step is to look closely at our resources – what we have in the way of physical buildings, financial resources, and people power. Then, decisions and prioritizing will be made on where and how to begin moving toward the future.

You church members will have the opportunity to follow through on what you said you thought our church should be and do by becoming part of something very special: praying and molding a goal into a reality!

"With God, all things are possible!"

It has been a privilege to work as a member of the Council Group who has met usually weekly since the summer 2000. This group has fed my spiritual soul as we have prayed, discussed and planned. I thank George Nassner, Council President for his guidance and perseverance and his belief and faith in God that we will be shown the way. I have benefited from working with the other members of the group, Olga deBloom, Denise Kelly and John Williams. (In the future, other congregational members will also participate in the Group.)

I take my hat off to all the Council members who have worked with increased trust, devotion and commitment. I thank Rob Gundlach and the choir for enhancing our souls and spirits during worship. Cass Young and Darlene Waters serve Christ with devotion by all that they do in the office *cheerfully and with a smile!*

A big thank you to Art and Lois Jones who always see, along with John Price and his committee, that the building gets cleaned and repaired, and with Olga deBloom and others who see that the kitchen stays in order and food is provided for fellowship times.

Then there are all those who serve in many, many ways, preparing for worship, ushering, counting money, planning fund-raisers, teaching and administering the educational program for children and adults, helping out in the office, assisting in the mailings, hosting the wonderful PACT program that Concetta Clark administers and providing for community Twelve Step programs .

Now you know I wouldn't end this report without sharing with you that I've never been part of a congregation who loves their church as much as you love this church. We are in all sense of the word a *family!* We care deeply about one another and do our best to show it. I was deeply touched with all your caring when my father died on February first. Wesley's recovery from difficult heart surgery was aided by your prayers and cards.

Besides working with the above named Council Committee, planning inspirational worship services which meaningfully follow the seasons of the church year is a priority. Another commitment is to provide pastoral care by visiting you in hospitals and homes which enables me to get to know you better and to pray with you. Teaching confirmation class, providing resources for council members to help them in their ministry, praying daily for you and for God's guidance in my ministry is always .

I want to thank Arlene Pate and Ruth Beckwith who assist me in caring for you. This year, with their help of purchasing, addressing and

providing postage, I have sent out over 600 cards of encouragement to members who are celebrating birthdays, or who have a concern or illness.

Most important is my goal to provide you with guidance in this time of transition, as a ministry takes shape that you will eventually invite another pastor to join you in who will guide you into a faithful future.


As I conclude, you know as well as I do that it will take the commitment of each person to move beyond just *standing* on first base. And so I still ask you the question,




