OUR MISSION TO OTHERS

1. *Our Christian World Mission.* Churches with Congregational Christian background should make no entries in this section. Your Conference or Acting Conference will report these figures directly to the Year Book office. Churches with Evangelical and Reformed background should report these amounts here, if known to them. Our Christian World Mission includes monies received from your church during 1963 for (a) the work of Conferences or Acting Conferences and (b) the regularly budgeted work of the Instrumentalities of the United Church of Christ. These are items which have been designated as "apportionment giving" in the past for the support of the work of denominational boards and agencies, including World Service.
2. *Other Denominational Gifts.* LOCAL CHURCH TO REPORT. Report the total amount contributed by your church to health, welfare and educational institutions *officially related to the United Church of Christ* and for other United Church of Christ causes which are not a part of the denomination's regularly budgeted work, such as CHEF and Racial Justice Now. If in doubt about the denominational relationship of an institution to which contributions were made, consult directories in the current Year Book of the United Church of Christ.
3. *Ecumenical Ministries.* The amount reported for Ecumenical Ministries should include only contributions to local, state, national and world councils of churches, non-denominational projects and agencies such as the American Bible Society, Y.M. or Y.W.C.A., or other community-wide religious agencies. *Do not include* funds contributed to agencies and causes which are *not primarily religious* organizations such as Boy and Girl Scouts, Red Cross, etc. in this column.

 12. *Debt on Property.* Please exclude the amount of all grant mortgages when computing the total amount of your indebtedness on church property as of December 31, 1963.
 13. *Legacies Received during 1963.* Report the value of all legacies received during 1963. This amount should be included in the total amount of invested funds reported in Line 14. Please report the current value of all invested funds.
