Gentlemen:

An inspection of your church revealed a heavy population of pigeons nesting and loafing on ledges, sills, and around/under air-conditioning units. We suggest that you consider an Avitrol program whereby the objective of this material is to create "flock frightening" and to move these dirty birds elsewhere.

To accomplish this, we would commence a feeding program on the parsonage roof and in the areaway between the school and church buildings. Once there is good acceptance of the feed, a proper mixture of Avitrol will be introduced. Please understand that the mixture would be so discreet that I suspect it would require several months before you would notice a reduction in your population. It would be easier to perform a more dramatic lowering of the population, but there is the accompanying disadvantage of having many "downed" pigeons on the streets and sidewalks of the neighborhood. In my opinion you would find this objectionable. It is our experience, in an urban location, that gradual movement is more desirable.

The charge for an Avitrol program would be \$148.00 for the first month, and thereafter \$55.00 per month based upon a yearly contract. Please understand that we are talking about a 90% reduction of your population of pigeons.
