

DO NOT INCLUDE CONTRIBUTIONS TO AMA since these will be included in the Year Book in a separate report.

In addition, please complete the information requested in the bottom right corner of Page 1 regarding your ministerial status and the date called to the church. Also, complete the form called Page 2. Please return both of these pages to the Conference Office by the end of January 1978. The other forms enclosed may be returned to the Conference Office at a later date, but no later than the end of February 1978.


