

INDEMNIFICATION AGREEMENT

This indemnification agreement is executed between "ALIVE IN CANTON, IT'S SAT. NITE" GROUP OF NA

All users/tenants of United Evangelical Church property shall to the maximum extent permitted by law, indemnify and save harmless the United Evangelical Church and all its trustees, officers, employees, volunteers, representatives, successors and assigns, against and from all costs, expenses, liabilities, losses, damages, injunctions, suits, actions, fines, penalties, claims and demands of any kind or nature, including reasonable council fees, by or on behalf of any person, party or governmental authority whatsoever arising out of ;

- (a)—Any accident, injury or damage, including without limitation injuries to persons and/or damage to property, which shall happen in or about the United Evangelical Church premises or appurtenances regardless of how it occurred.
- (b)—Accident damages or injuries occurring on the way to or from a meeting at the United Evangelical Church.

ADDITIONALLY

- (a)—All users/tenants shall set up and take down the chairs and tables and leave the premises as they found it.
- (b)—No user/tenant shall use kitchen equipment or appliances belonging to the Church unless given permission by proper authority.
- (c)—No Church equipment is to be removed from the premises unless given permission by proper authority.

INDEMNIFICATION AGREEMENT

This is a statement of agreement between United Evangelical, United Church of Christ and Casa de Restauracion Four Square Gospel Church for the use of space at 3200 Dillon Street, Baltimore, MD 21224. Casa de Restauracion agrees to compensate United Evangelical Church \$500 per month for use of facilities detailed below:

- Sanctuary – Sundays 3:00 - 5:00 p.m.
- School Building – Sundays 3:00 - 5:00 p.m.
- Friendship Hall – Sundays 5:00 - 6:00 p.m.
- School Building – Wednesday 6:00 - 9:00 p.m.
- Friendship Hall – Fridays 7:00 - 9:30 p.m.
- School Building – Fridays 7:00 - 9:30 p.m.

Either party can terminate this agreement at anytime with a 30 days notice.

Casa de Restauracion shall, to the maximum extent permitted by law, indemnify and save harmless the United Evangelical Church and all its trustees, officers, employees, volunteers, representatives, successors and assigns, against and from all costs, expenses, liabilities, losses, damages, injunctions, suits, actions, fines, penalties, claims and demands of any kind or nature, including reasonable council fees, by or on behalf of any person, party or governmental authority whatsoever arising out of:

- Any accident, injury or damage, including without limitation injuries to persons and/or damage to property, which shall happen in or about the United Evangelical Church premises or appurtenances regardless of how it occurred.
- Accident damages or injuries occurring on the way to or from a meeting at the United Evangelical Church.

ADDITIONALLY

- All users/tenants are required to have liability insurance.
- All users/tenants must set up their own chairs and tables and leave the premises as they found it.
- No user/tenant shall use kitchen equipment or appliances belonging to the Church unless given permission by proper authority.
- No Church equipment is to be removed from the premises unless given permission by proper authority.
