DEVOTION: Rev Cathy Oatman led Council in opening prayer.

MINUTES: Vote made by Jennifer Borkman to accept minutes from May 11, 2021 meeting and seconded by Scott Johnson.

FINANCIAL REPORT: Financial report as of May 2021 reviewed by Council. It was noted that the church is \$1,022 in the red for the first 5 months of the year. Council president moved and Travis Hogan seconded that the financial report be accepted.

OLD BUSINESS:

The upper room has been painted and the floor was stripped and waxed.

We had our first young person in child care during church on June 13th.

There are a lot of items to be moved from the Sunday School Building to the new storage areas in the church building.

On June 2nd, we received a letter from WesBanco Bank Inc. stating that our loan for the amount of \$9,522 in principal and \$100.70 in interest has been forgiven.

Ongoing maintenance has to continue on the interior and exterior of the church building: Grass in the cracks outside, drain in between the buildings, no chipping or missing paint on the light fixtures.

Rob emailed a list updating the status of the audio/visual room conversion. Travis and Rev. Cathy will be coming on June 17th to paint the room. Rob will be taking vacation August 8th, August 15th and August 22nd. + 29th

The Flea Market will be held on Saturday, June 19th.

Update for the sale of the Sunday School building: We should receive the Condo Documents by the end of June for review at the next meeting.

NEW BUSINESS: None

ENDOWMENT: Barb Matthews is going to set up a second investment account after the sale of the Sunday School building. The minimum to setup the account is \$1,000.

PROPERTY: Scott spoke to the tenants in the parsonage. They are unable to sign a new one year lease. Scott offered a 6 month lease and to date has not heard back from them.

The old boiler, fridge and freezer have been removed from the hall. Scott also repainted the floor in the boiler room.

MUSIC: We are looking into who is going to cover Rob's vacation in August.

EDUCATION: Starting in September, Sunday School will be held in the upper room from 9 am-10 am.

MISSIONS: In July and August we will be collecting school supplies. Abbey has the list and will include it in the bulletin.

PASTOR'S REPORT: Rev. Cathy will be on vacation from June 28th through July 12th. We will be sending out the benevolences for the second half of the year. June 26th we will be having the Lock-In and June 27th we will be having a farewell celebration for Cathy Fifield. The scholarship presentation will be held on August 1st. *release of building*
