**\* WARNING**

**ANY HOLDER OF A PERMIT WHO IS REQUIRED TO PAY A FEE FOR THE PERMIT AND WHO FAILS TO RENEW THE PERMIT WITHIN FIVE (5) DAYS FOLLOWING THE EXPIRATION DATE OF THE EXISTING PERMIT SHALL BE ASSESSED A LATE FEE OF TWENTY DOLLARS (\$20.00) PER DAY FOR EACH DAY FOLLOWING THE EXPIRATION DATE OF THE EXISTING PERMIT.**

**AN ADDITIONAL CHARGE WILL BE IMPOSED ON EACH PERMIT PAID BY A CHECK WHICH IS DISHONORED.**

**EXAMPLE**

**FEE IF PAID BY THE:**

**\* 6<sup>TH</sup> DAY FOLLOWING DATE OF EXPIRATION = \$120.00 + PERMIT FEE**

**7<sup>TH</sup> DAY FOLLOWING DATE OF EXPIRATION = \$140.00 + PERMIT FEE**

**10<sup>TH</sup> DAY FOLLOWING DATE OF EXPIRATION = \$200.00 + PERMIT FEE**

**15<sup>TH</sup> DAY FOLLOWING DATE OF EXPIRATION = \$300.00 + PERMIT FEE**

**30<sup>TH</sup> DAY FOLLOWING DATE OF EXPIRATION = \$600.00 + PERMIT FEE**
